B.Th. Paper

To obtain the B.Th. degree every student is required to write a paper according to the demands of scientific methodology, under the direction of a member of the teaching staff.

The topic of this paper should be sufficiently general and wide so that a comprehensive scriptural and theological presentation is possible. It is not the scope of this paper to study in depth any particular problem whether scriptural, theological or missiological. Such a problem can at best serve as a point of departure for a general exposition of scriptural and theological principles or as a field of application of such principles.

The length of the paper should be about 10,000 words, about 40 typed pages and not more. The topic chosen for study, along with the name of the moderator, should be submitted to the President for approval before commencing the work. Two copies of the final draft are to be handed over to the office of the Registrar. It is the responsibility of the student to ensure that the thesis is written in readable and correct English. The thesis should be submitted to the office by the end of May of the 6th semester.

Comprehensive Examination in Scripture and Theology

A student will be admitted to the comprehensive examination only after he/she has successfully completed all the individual courses and the B.Th. Paper. The examination consists of a 30 minutes viva examination before a panel of at least two examiners. The questions will be based on prescribed themes from Scripture and Systematic Theology and a discussion on the B.Th. thesis. The aim of the examination is to ascertain whether the student has arrived at a synthesis as a result of his study of Scripture and Theology.

The final evaluation of the B.Th. degree course will be as follows:

50% of the aggregate of the semester marks of the individual courses,

25% of the B.Th. Paper, and

25% of the Comprehensive Examination.
